Every year, over 30% of Gordonstoun pupils receive financial help through bursaries. This is vital for keeping the school as diverse as possible, by welcoming children from all walks of life, regardless of their financial background. Funding for bursaries comes from a variety of sources;

School Income: Funding bursaries, to give those who otherwise couldn't afford it the opportunity to attend Gordonstoun, is part of our founding ethos. We continue Kurt Hahn's philanthropic mission to this day, by spending a substantial proportion of our income on bursaries.

Trust & Foundations: Gordonstoun actively seeks grants from various charitable trusts and foundations that support education initiatives.

Legacies: Anyone that wishes can leave a legacy to the school in their Will, through the Kurt Hahn Foundation. You can specify what you would like it used for and, at certain levels, it is possible to have a named bursary.

Fundraising: We work hard to fund bursaries through the above means, but more is needed. Gordonstoun does not have an endowment fund that we can draw from, so fundraising and the support of the Gordonstoun family is crucial. Through donations, you can help us support even more students on bursaries and at the same time, allow us to spend more of our income on improving our campus and facilities for current and future students.
