If you decide to leave a legacy to Gordonstoun we would be grateful if you would inform us by completing our Legacy Form and sending it to the address below.

We would like to ensure that your bequest is used in an area that you wish to support and would be pleased to arrange a meeting with the Patron or Co-ordinator of the Kurt Hahn Foundation to discuss your gift.

When you have decided what type of legacy you intend to leave, please contact your lawyer. The school advises that you should seek legal guidance from your own legal advisor regarding the nature and terms of your bequest, in the context of estate and tax planning and obligations you may have to family and others.

Writing your Will

You can write your Will in several different ways; leaving a fixed amount; a bequest in kind; or the residue of your estate. If you have already made a Will you can make a simple addition to your existing will called a Codicil. You may add more than one Codicil to your Will.

It is always advisable to seek professional advice from your legal advisor and we urge you to do so, to ensure that your wishes are complied with.

Definitions:

Term	Definition	Suggested Wording
Pecuniary Will	Fixed sum of money, a property or other specific item.	“I bequeath to The Gordonstoun American Foundation, registered as a non-profit organisation Tax ID #22-253 5233, the sum of \$.....”
A Bequest in Kind	A gift of something specific which you own, such as shares in a company, a book collection, a house of land.	“I bequeath to The Gordonstoun American Foundation, registered as a non-profit organisation Tax ID #22-253 5233, the gift of”
Residuary Will	The residue of your estate after specific bequests made to family and friends. This may be in the form of a % of your estate and may not need updating unlike a Pecuniary Will, where you have bequeathed a fixed sum. You may wish to allocate a % of your estate to more than one charity.	“I bequeath to The Gordonstoun American Foundation, registered as a non-profit organisation Tax ID #22-253 5233, the residue of my estate.” Or “I bequeath to The Gordonstoun American Foundation, registered as a non-profit organisation Tax ID #22-253 5233,% of the residue of my estate.”
